## Season Overview

Congratulations to all USAGW athletes entering the 2019-2020 season and the best of luck to you. The following packet contains the information needed for participation in the upcoming season. This information will help ensure an organized and successful competitive year. Please read ALL parts of this packet to avoid any confusion.

**Competition Schedule** – This page contains information about each meet that the teams will be attending. As more information becomes available, you will be updated on dates, locations, session times, etc....

**Uniforms** – The attached page has the 2019-2020 competition wear for the USAGW Men and includes apparel details. All boys will be fitted for singlet, shorts, pants and warm-ups on a date specified by General Manager, Emily Schoenwald. Please note the due date for uniform cost and fees is listed on your Season Payment Breakdown page.

**Season Payment Breakdown** – This page contains a financial breakdown of the competitive season. The fees listed cover all meet entries, USAGW summer camp, coaches' fees, coaches' travel, etc. up to the National Championships. Coaches fees for the Region and National Championship will be covered by the before mentioned fees but any boys qualifying to the meet must still pay an entry fee to attend the competition due at the conclusion of the State and Region Championships. All levels 5-10 that qualify for Region and National Championships are expected to attend and will be charged. This page also contains the breakdown and schedule for all team fees due. Payments consist of 6 installments spreading the cost of the season over a five-month period. There will be a 7<sup>th</sup> payment due that volunteer hours can be applied towards. Region entry fees will be due in March.

To keep costs for the team as low as possible, all meets on the schedule are mandatory. If for some reason a gymnast must cancel a meet due to of a conflict or injury, the athlete is **STILL REQUIRED TO PAY ALL TEAM FEES** so as to keep all cost consistent throughout the season. **ALL TEAM FEES PAID ARE NON-REFUNDABLE.**
